Personal data gathered by us

FirmCC bv gathers (saves and uses) your personal data because you yourself have provided it and/or because you make use of our services.

The information involved includes: first name and family name, e-mail address, addresses of social media accounts if any, and telephone number(s).

If any business transactions take place between us (i.e. if you become a customer or supplier) the data required for such transactions, such as name of business, bank account details, VAT number and COC registration number may also be saved.

The purposes for which we process personal data

FirmCC processes your personal data for the following purposes:

- Implementation, improvement and administrative handling of the service provision;
- Provision of information about new and existing services and activities;
- Protection and improvement of our website to meet legal obligations.

Sharing of personal data with third parties

FirmCC will not sell your data to third parties, and will pass it on only if this is required for the execution of our agreement with you or to meet a legal obligation. We do conclude data processing agreements with third party businesses for the processing of your data by our order to ensure a consistent level of protection and confidentiality, but FirmCC remains responsible for such processing at all times.

Cookies or similar technology used by us

FirmCC uses functional and analytical cookies. A cookie is a small text file saved in the browser of your computer, tablet or smartphone upon your first visit to the website.

FirmCC only uses cookies with a purely technical function: they ensure, for example, that the website functions correctly and optimally, and that your preferred settings are retained.

These cookies are anonymised, which means that they cannot be traced back to your personal data.

You have the option to sign out from cookies by setting your internet browser so that it no longer saves them. In addition, it is possible to remove all previously saved information via your browser settings. Please go to:
